- **MAKE YOUR VOICE HEARD!**

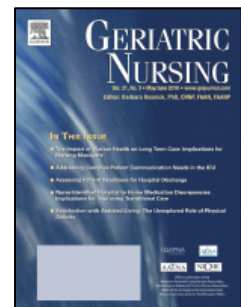
